- **Concert Decorations** – For the Kyiv Chamber Choir concert on Sunday December 4th, President Pucher asked Mike Jackiw if he would arrange to have three decorated/lighted Christmas Trees in Church. Richard will meet with Mike to tell him where the trees should be located.
- **Church Envelopes** – Church envelopes for 2012 will be labeled and arranged for pick up on Wednesday December 7th.
- **Parish Christmas Party** – This year's Christmas Party will be opened up to the Parish and be sponsored by the HNS. Date will be December 11th starting at 1 PM. Cost of Party will be \$15 a person which will include buffet/refreshments/snacks.
